Leigh Roberts CEO, IRC of South Africa



Leigh has been deeply involved in the development of integrated reporting in South Africa and internationally. She is a founder with Professor Mervyn King of the Integrated Reporting Committee (IRC) of South Africa and is its current CEO and the chair of the technical Working Group. She is a member of the International Integrated Reporting Council's (IIRC) Framework Panel which is currently looking at the revision of the International <IR> Framework. Leigh was involved in the development of the original International <IR> Framework released in 2013 as a member of the IIRC's Technical Task Force and Working Group.

Leigh has co-authored two books with Professor Mervyn King: Integrate: Doing Business in the 21st Century (Juta) and The Healthy Company. She has run board and executive training sessions in South Africa and internationally and is a training facilitator for the Institute of Directors in South Africa and the JSE. She has adjudicated for the CSSA Integrated Reporting Awards in the Top 40 Listed Companies category and has contributed to numerous publications internationally. Leigh is a Chartered Accountant (South Africa).

Professor Mervyn King Chairman of the Integrated Reporting Committee (IRC) of South Africa



Mervyn is the Chair of the Integrated Reporting Committee of South Africa, Chair of the African Integrated Reporting Council and Chair Emeritus of the King Committee on Corporate Governance in South Africa. He is Chair Emeritus of the International Integrated Reporting Council (IIRC) and of the Global Reporting Initiative, and a member of the Private Sector Advisory Group to the World Bank on Corporate Governance. He is the Patron of The Good Governance Academy.

Mervyn is a Senior Counsel and former Judge of the Supreme Court of South Africa. He is Professor Extraordinaire at the University of South Africa on Corporate Citizenship, Honorary Professor at the Universities of Pretoria and Cape Town, a Visiting Professor at Rhodes and a professor at the Wits Business School at the University of the Witwatersrand. He has received honorary doctorates from a number of universities around the world. He has received Lifetime Achievement Awards for promoting quality corporate governance globally from the ICGN and other organisations, as well as a number of honorary fellowships and international awards.

He chaired the United Nations Committee of Eminent persons on Governance and Oversight and was President of the Advertising Standards Authority for 15 years and a member of the ICC Court of Arbitration in Paris for seven years. He has been a chair, director and chief executive of several listed companies. He has consulted, advised and spoken on legal, business, advertising, sustainability and corporate governance issues in over 60 countries. He sits as an arbitrator and mediator internationally. He is the author of six books on governance, sustainability and reporting.

Professor Mark Graham Associate Professor at UCT's Graduate School of Business



Mark Graham is an Associate Professor at UCT's Graduate School of Business. He is a former Head of the College of Accounting at the University of Cape Town. He teaches on the MBA, EMBA and various Executive programs at UCT's Graduate School of Business. He qualified as a Chartered Accountant (SA) in 1987, and between 1988 and 1993 held a number of senior financial positions with firms in the United Kingdom. He holds an M.Com in Financial Management. He consults to the accounting profession and regularly presents courses on various aspects of accounting and integrated reporting, both public and in-house. He is the former chair of the Association of Heads of Accounting in South Africa. Mark has been involved with EY's Excellence in Reporting awards since its inception in 1997 and is the current chair of the adjudication panel for the annual EY's Excellence in Integrated Reporting awards. In his spare time he rides his mountain bike, birdwatches and spends time in the Southern African bush.

Alfred Visagie Head: Investor Relations, Nedbank Group



Alfred has been involved in financial markets since 1998, starting his career as an investment analyst at ABN AMRO where he was a rated analyst in the Electronics sector of the JSE, before joining Nedbank Group in 2000. At Nedbank, Alfred had two key roles - the first was establishing the group's strategy unit where he worked on the Nedbank turnaround in 2002/3, landed the new corporate strategy and prepared the group's business plans. The second key role since 2011, and his current position, is head of investor relations. Under Alfred's leadership the group has received more than 35 reporting awards over the years, establishing Nedbank as a leader in reporting and communication with the investment community.

Before moving to Australia, Leila served on the Board of the Johannesburg Stock Exchange as Executive Director. Leila previously worked for one of South Africa's largest banks, Standard Bank, as Card Division Managing Director. During this time, she served as Chairman on the board of Diners Club and Board Member on Discover's Chicago-based Diners Club International Advisory board. Leila started in Standard Bank's Investment Bank as Global Director Credit analytics, capital and portfolio management for SA, UK, Hong Kong, Russia, Brazil and Argentina.

Leila has a PhD in Economic and Financial Sciences and won the Economic Society South Africa Founders' award in 2012 for best Masters Economics thesis in the country. Leila has published several articles in academic journals and actively advocates for policy development in various sectors.
